1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Description	The property is a purpose built two storey ex local authority mid terrace house. We understand the property to be of non traditional construction, namely wilson block.
Accommodation	The accommodation comprises of : entrance hall, living room, kitchen, three bedrooms and bathroom.

Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property.

If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The main roof is timber framed, pitched and finished with clay roof tiles.

Flashings to roof are lead.

As per our inspection, we assume that the roof and subsequent roof void areas are maintained by the building factors. It would be prudent to have your legal advisor determine this prior to legal commitment to purchase.

Limited roof inspection carried out via access hatch, 200mm Insulation materials noted at the joists.

Rainwater fittings

Visually inspected with the aid of binoculars where appropriate.

The rainwater fittings are formed in UPVC & Cast Iron construction, of half round design leading to downpipes.

Main walls

Visually inspected with the aid of binoculars where appropriate.

Foundations and concealed parts were not exposed or inspected.

The main walls are approximately 300mm system built construction. We understand the property to be of no fines, wilson block concrete construction.

There is evidence of filled wall insulation. Your legal advisor should verify the type of insulation used and the existence of any guarantees.

Windows, external doors and joinery

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible.

Doors and windows were not forced open.

The windows are uPVC double glazed throughout.

Physical access to the sub floor area may be taken if the Surveyor deems it safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

The floors are of solid concrete on the ground and suspended timber on the first floor.

Most floors were covered with carpets or fixed floor coverings which were not lifted. Consequently floor surfaces and sub floor areas could not be inspected.

Internal joinery and kitchen fittings

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Internal joinery is of conventional type and design.

Kitchen units comprise wall and base units.

Chimney breasts and fireplaces

Visually inspected.

No testing of the flues or fittings was carried out.

There is a chimney breast and fireplace located within the lounge. The fireplace has a timber surround and has been fitted with an electric fire.

Internal decorations

Visually inspected.

Internal decorations comprise of paint on the woodwork, walls and ceilings.

Wallpaper has been applied to one or more walls.

Artex was noted on the ceilings which could contain asbestos. This is not normally considered to be a health hazard provided they are not disturbed. For example, they should not be rubbed down during redecoration.

Tiled/wet wall finishes have been applied to splash areas in the kitchen and bathroom.

Cellars

Visually inspected where there was a safe and purpose-built access.

Not applicable.

Electricity

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

The property is served by a mains 13amp electricity supply. The meter and consumer unit is in the hallway.

Wiring where seen is sheathed in PVC.

No tests have been carried out confirming adequate smoke and fire detection measures are in place to comply with Scottish Government standards. Applicable from February 2022.

Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

The property is served by a mains gas supply with the meter located externally to the front of the property.

Water, plumbing, bathroom fittings

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

Mains water supply.

Sanitary fittings have chrome fittings and include WC, wash hand basin and bath.

Plumbing where seen is run using modern polythene and copper pipe work using push and fit connectors.

Internal stopcock was not located. If discovered one does not exist you should arrange for its installation.

Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

Central heating and hot water is provided by way of gas fired central heating system (Vokera Excell 25) located within the kitchen.

Drainage Drainage covers etc. were not lifted. Neither drains nor drainage systems were tested. Drainage is assumed to connect to the main public sewers. No evidence of leakage or blockage at the time of inspection. Fire, smoke and burglar alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

Smoke alarm noted.

Carbon monoxide detector.

Any additional limits to inspection

For flats / maisonettes. Only the subject flat and internal communal areas giving access to the flat were inspected. If the roof space or under-building / basement is communal, reasonable and safe access is not always possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation. The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

The property was occupied and access was limited by furniture and contents.

Inspection was restricted due to high volume of stored goods.

The presence of floor coverings throughout prevented a full inspection. Floor coverings were not lifted.

An inspection for Japanese Knotweed was not carried out. This is a plant which is subject to control regulation, is considered to be invasive and one which can render a property unsuitable for some mortgage lenders. It is therefore assumed that there is no Japanese Knotweed within the boundaries of the property or its neighbouring property. Identification of Japanese Knotweed is best undertaken by a specialist contractor.

The report does not include an asbestos inspection. However asbestos was widely used in the building industry until around 2000, when it became a banned substance. If the possibility of asbestos based products has been reported within the limitations of the inspection and you have concerns you should engage a qualified asbestos surveyor.

Where walls are lined internally with tiling, plasterboard or timber the structure behind cannot be seen or tested. Consequently the condition of such hidden areas cannot

be confirmed an inspection is recommended to be made before your Legal commitment to purchase.

Only a limited view of upper elements was available from the ground.



	As per our inspection, we assume that the roof and subsequent roof void areas are maintained by the building factors. It would be prudent to have your legal advisor determine this prior to legal commitment to purchase. Limited roof inspection carried out via access hatch 200mm Insulation materials noted at the joists. As such no detailed comment can be passed on the condition of the roof structure, timbers or insulation materials etc. This area should be checked prior to purchase. Surrounding properties have undergone a programme of external refurbishment indicating that the external features may be nearing the end of their useful life. Consideration should be given to external
	refurbishment of the building as part of a communal repair scheme. Your legal advisor to verify if such works are planned.

	Repairs are required at the open joints to alleviate the effects of water penetration and frost damage, and provide adequate protection to the underlying brickwork. Further enquiries with the Management Company are recommended.
	Surrounding properties have undergone a programme of external refurbishment indicating that the external features may be nearing the end of their useful life. Consideration should be given to external refurbishment of the building as part of a communal repair scheme. Your legal advisor to verify if such works are planned. 4. Valuation and conveyance issues

Estimated reinstatement cost for insurance purposes

The estimated rebuilding cost of the Property for insurance purposes is £189,000 (One Hundred and Eighty Nine Thousand Pounds Sterling).

This figure is calculated on the basis of equivalent modern reinstatement using the BCIS House Rebuilding Cost Index.

This figure is for guidance only as it is assumed the building is insured under a single policy.

Valuations and market comments

It is necessary for applicants to satisfy themselves that suitable lending for mortgage is available for the subject property prior to purchase, as no checks have been made by us in this regard. Should the property be deemed unsuitable for Mortgage purposes this may impact the valuation figure below and we reserve the right to adjust the valuation accordingly.

PART 1 – GENERAL

1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report and Energy Performance Certificate in the format prescribed by the accredited Energy Company.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon Residential Property. (1)

If the Surveyors have had a previous business relationship within the past two years with the Seller or Sellers Agent or relative to the property, they will be obliged to indicate this by ticking the adjacent box.



The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 THE REPORT

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

To date, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Single Survey is instructed by the Seller and made available to all potential Purchasers in the expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Surveyor will also be entitled not to proceed if after arriving at the property, the Surveyor concludes that the property is exempt under Part 3 of The Housing (Scotland) Act 2006 as detailed in the (Prescribed Documents) Regulations 2008. If there is a potential threat to their health or personal safety, the inspection may be postponed or cancelled, at the Surveyor's discretion.

In the case of cancellation or the inspection not proceeding, the Surveyor will refund any fees paid by the Seller for the inspection and Report, except for expenses reasonably incurred and any fee due in light of the final paragraph of this section.

In the case of cancellation by the Seller, for whatever reason, after the inspection has taken place but before a written report is issued, the Surveyor will be entitled to raise an invoice equivalent to 80% of the agreed fee.

1.7 PRECEDENCE

If there is any incompatibility between these Terms and Conditions and the Report, these Terms and Conditions take precedence.

1.8 **DEFINITIONS**

- The "Lender" is the party who has provided or intends or proposes to provide financial assistance to the Purchaser towards the purchase of the Property and in whose favour a standard security will be granted over the Property;
- the "Market Value" is the estimated amount for which a property should exchange on the date of valuation between a willing buyer and a willing seller in an arms-length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion;
- the "Property" is the property which forms the subject of the Report;
- the "Purchaser" is the person (or persons) who enters into a contract to buy the Property from the Seller;
- a "prospective Purchaser" is anyone considering buying the Property;
- the "Report" is the report, of the kind described in Part 2 of these Terms and Conditions and in the form set out in part 1 of Schedule 1 of the Housing (Scotland) Act 2006 (Prescribed Documents) Regulations 2008;
- the "Seller" is/are the proprietor(s) of the Property;
- the "Surveyor" is the author of the Report on the Property; and

1.9 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

1.10 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible – in other words, visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

2.0 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any minor defects.





The energy efficiency rating of your home

1 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions.
